The 26th Annual Cherry Blossom Festival was held at the Seattle Center on April 20-22. This year's festivity was a resounding success. Thousands of folks flocked to three Seattle Center venues to take part in a wonderful exhibition of Japanese culture and arts.

It would be impossible to pinpoint the Festival's highpoint. The special exhibition of Japanese ceramic masters was simply breathtaking. The ongoing entertainment was top notch. The art and craft demonstrations were awesome. The presentations by the chefs from the Japanese Restaurant Association were so skillful that it was hard to know if you were viewing a culinary presentation or a beautiful art demonstration.

The Festival also showcased aspects of the Japanese American experience with photo displays and informational tables set up by groups such as the Bainbridge Island Japanese American Community, the Lake Washington JACL, Nikkei Concerns and others. A unique virtual reality presentation titled, "Beyond Manzanar" offered a nonlinear look at the concentration camps from various times and different perspectives, eventually weaving in the feelings of mistrust towards Iranian Americans during the hostage crisis. It was a thoughtful reminder of the vigilance needed to protect civil liberties.

The Seattle JACL sold sushi bento boxes at the Festival and also up an informational chapter display. Thanks to the help of many

# Six National Youth/Student Conference scholarships available

A generous anonymous donor has recently agreed to offer three commuter package scholarships for the upcoming JACL National Youth/ Student Conference in Seattle. The commuter package scholarships cover all expenses for meals, conference fees, and parking.

The generosity of this donor will go really far in helping the JACL get new young people involved. It is my hope that this opportunity to attend the upcoming national conference free of charge will allow some new young people or even young people who are already members to come and see all of the programs that JACL has to offer. The conference itself will be a really exciting event to be a part of.

This is the first time in several years that the JACL National Youth/ Student Conference is being held in Seattle. The previous two biennial National Youth/ Student Conferences were held in Los Angeles in 1999 and 1997.

In addition to the above mentioned scholarships, the Seattle—hapter Board recently agreed to match the anonymous donor's generous gift, announcing that the Seattle Chapter would award three full package scholarships for the conference. The full pack-

age scholarships cover all expenses for the conference, including two-night stay, meals, and conference fees.

The JACL National Youth/ Student Conference will be taking place July 13-15, at Seattle University with the theme, "Transforming Leadership in the Asian Pacific American Community through Unity, Identity, and Diversity." The conference will provide workshops, forums for discussion, and exciting speakers from the Asian Pacific American community. It will be geared toward the needs and interests of youth and students between the ages of 16-25. Some of the workshop topics that the conference will cover include: Taiko as a Japanese Art Form, The Gaps in Our Generations, Hapa Issues, Getting Involved in College Organizations, the Importance of Graduate School, and Political Empowerment.

Scholarships will be awarded on a first-come, first-served basis. The Seattle Chapter requests that recipients of conference scholarships become JACL members. JACL is open to all people who are interested in protecting the civil rights of others. Individuals need not be Japanese American to become a part of JACL.

## **Proposed Bylaws Changes**

At the April 2001 Board meeting, the Bylaws Committee presented or comments, please feel free to join us at our next board meeting on hanges to the current Bylaws. These changes have been made to enre that our by-laws are consistent with our present practices. The board voted to recommend these changes to the general membership. We welcome your feedback at this time. If you should have questions

March 6, 2001 **Proposed Bylaws Changes** 

Article III, Section 2: (b) Special members-Non-citizen residents of the United States who desire to become associated with the Chapter.

Section 2, last paragraph: Except as otherwise provided for in these Bylaws, only active, special, booster, senior citizen, and student members shall have the right to hold office, and only active, special, booster, senior citizen, and student members shall have the right to vote.

Section 3: Applications for membership shall be made in such form as prescribed the board. All memberships shall be on a 12-month basis except for honorary memberships, which are effective for the life of the individual.

Article IV, Section 2: The number of directors shall be forty (40), consisting of eleven (11) officers, twenty-one (21) elected directors, and eight (8) directors appointed by the President with the approval of the elected directors and officers. Directors shall be elected and appointed annually and the term of each director shall be for the subsequent calendar year or until election and qualification of his/her successor.

Article VI, Section 4: The chairperson of each committee shall be appointed by the respective officer to whom the committee reports.

Article V, Section 3: All active, special, booster, student, and senior members are cligible to hold any office; provided, that the President, President-Elect and Vice Presidents, shall be twenty-one (21) years of age or older.

ticle VII, Section 2: Written or printed notice stating the place, day and hour he meeting and, in case of a special meeting, the purpose or purposes for which the meeting is called, shall be delivered not less than seven (7) nor more than fifty (50) days before the date of the meeting, either personally or by mail by the Corresponding Secretary, who shall be acting at the direction of the individual or individuals calling the meeting who shall also set the place, day, and hour of the meeting.

Article IX, Section 2: The Board shall determine annual Chapter dues.

Article XII-Misconduct, Section 1: Any officer or director neglecting his or her duties or any member who is guilty of misconduct reflecting on the good name of the Chapter shall be subject to sanction which can include recall or expulsion.

Section 2: A written and signed complaint by any member in good standing shall be filed with any officer who shall present the same at the next meeting of the Board. If the Board decides to take action, the President shall appoint an ad hoc committee to address the complaint. The committee shall send the concerned individual a copy of the complaint; and such individual shall have the opportunity of answering the complaint at the next Board meeting. The ad hoc committee shall report their findings at the next Board meeting and the individual shall have an opportunity to address the complaint and findings. The ad hoc committee will present its recommendations to the Board. The Board shall then vote on appropriate actions or sanctions. A three-fourths (3/4) majority of the Board present is needed to enact sanctions.

Section 3: If a sanctions motion fails to attain a three-fourths (3/4) majority vote the issue is considered closed.

#### SEATTLE CHAPTER JACL OFFICER RESPONSIBILITIES PRESIDENT

The President shall preside at all meetings of the Board of Directors, all general meetings of the membership and Executive Cabinet meetings. S/he shall, with the Treasurer, sign leases and contracts approved by the Board of Directors. S/he shall be an ex-officio member of all committees (and of the Advisory Board) and cultivate leadership among members of the Board. S/he shall attend community meetings on behalf of the organization and be a spokesperson at such meetings. S/he shall assure that the annual report is filed and minutes and other records are

#### VICE PRESIDENTS

Responsibilities:

For all vice-presidents, add to responsibilities "...solicits and appoints chairperson of each committee assigned."

All vice-presidents will monitor the activities of their respective assigned stand ing JACL Committees/Activities. A brief progress report on their committees will be made at each board meeting.

TREASURER (last paragraph): The Treasurer shall assist the President and designated board members in developing an annual budget in managing the endowment fund.
