Videotapes of Medal of Honor ceremonies available through Nisei Veterans Committee

The Nisei Veterans Committee is now taking orders for its outstanding video, "America at its Best" — a legacy of two Nisei patriots. The videotape documents the Medal of Honor ceremony at the Seattle Center Arena earlier this year and the dedication ceremony to rename the Seattle Federal Courthouse in honor of Pfc. William Nakamura.

The prologue introduces the subject matter of the vidcape:

"Fifty-six years after their heroic acts were officially cited, 22 Asian American soldiers were awarded the Medal of Honor. In the spring of 2001, two historic events celebrated the heroism of Washington State native sons Pfc. William Nakamura and T/5 James Okubo. During these events the saga of the Japanese American experience unfolded in the telling of the valor of the Nisei soldiers during WW II, revealing a profound portrait of Freedom's soul."

Chapter Permanent Site Committee meets

The ad hoc Permanent Site Committee met on Oct. 10th to discuss the issues regarding establishing a permanent home for the Seattle JACL. Those attending were Akemi Matsumoto, Arlene Oki, Bill Tashima, Ray Ishii, Jeffrey Hattori, Sue Taoka, and myself. We talked about what JACL needed in terms of space for archives, office or cooking facilities, hosting functions, and parking. We discussed the need for a survey of the general membership to find out what they wanted in a permanent site. We also mentioned the possibilities of sharing a potential space with other API or civil rights agencies.

The general recommendations were:

- 1. A permanent site committee should be formed. It would include those with expertise in real estate, financing and fund raising, and community development.
- 2. Pursue a study, using a consultant, to determine the feasibility of fund raising and potential site identification.
- 3. Discuss with other API civil rights oriented groups if they would be interested in being tenants at JACL's site.
 - 4. Begin looking at potential sites.

If you have any comments or suggestions or want to be involved let me know.

Tatsuo coordinated the National JACL Youth/Student Conference held at Seattle University this summer. His goals for our chapter are to continue to see it grow and be at the forefront of civil rights issues.

SHEA AOKI is a lifetime member of JACL and has been involved for over 60 years. She has served on almost all of our committees but most notable are the Cherry Blossom committee for over 25 years, the Endowment committee from 1988—1994 and serving as Chapter Historian for many years. Shea went to the Dhursttle Designing and Tailoring School and she still occasionally works when she is needed. Shea is also a volunteer at Keiro Nursing Home and is active in the Japanese Episcopal Church community.
