ur Board retreat this past month helped get the new board grounded and focused on the work that lies ahead. In addition to spending quality time, sharing our personal stories, and familiarizing ourselves with the overall operations and structure of JACL, a substantial portion of our day was spent prioritizing our goals for the coming year. What emerged was a strong commitment to maintaining and upholding civil liberties and civil rights, as well as serving our JACL membership in meaningful ways.

Though we are still refining our ideas, some of the common goals include:

#### **Civil Liberties**

- Work to support the Washington State Civil Liberties Project;
- In coalition with Arab American and Pan-Minority communities, monitoring hate crimes and incidents of racial profiling. Raise awareness of hate crimes through educational rallies, events and speakers;
- Serve as a watchdog on anti-terrorism measures in Washington State;
- Monitor employment lawsuits;
- Monitor movement in affirmative actions; and
- Promote Japanese Americans/Asian Pacific Islanders in public and private employment opportunities. Monitor vacancies and positions in public office.

#### Membership

- Increase membership including youth and Kaizen members. Reconnect with past scholarship recipients. Increase outreach to Hapas and the GLB community;
- Increase fund-raising efforts;
- Secure a permanent home in either a cultural center or JACL owned building. Research possible partnerships;
- Hold more multiple generation family events such as Mariners events or sports tournaments; and
- Increase public relations efforts of JACL.

We need you involved: Committees are open to members and the public. All are welcome, there is plenty of work, and we encourage everyone to take a place around the table. Please join in.

# **Historical Booklet**

ACL members and friends, a project that was completed in 2001 by the Seattle Chapter JACL was the publication of a concise history of the Seattle JACL from 1921-2000. A history of the early beginnings up to 1982 was originally published as the 60th Anniversary Booklet in 1982. When we began plans to reprint the booklet for the 79th Anniversary Installation Banquet, there were many requests to update the history to the current period.

After many months of hard work by committee members, volunteers, and past presidents and officers, the project was completed. In an abbreviated form, the booklet covers the Chapter's activities since 1921, continually in the forefront in the fight for civil rights. JACL's wartime role is detailed as well as its subsequent success for issei naturalization through the Walter-McCarran Act. Sponsorship of the Pride and Shame Exhibit and the Japanese Cherry Blossom and Cultural Festival are highlighted. Seattle JACL members were a driving force in the passage of the Civil Liberties Act of 1988 and these significant events are chronicled.

In the 80's and 90's Seattle JACL's activities are summarized under each Chapter President's year covering issues such as: fighting hate crimes, monitoring the media for racial stereotyping, building coalitions with other ethnic and civil rights organizations, fostering youth education with scholarships, and numerous other related issues.
