Governor Gary Locke, Army Chief of Staff Eric K. Shinseki, and Mrs. Nobuyo Okubo, Technician Fifth Grade (T/5) James K. Okubo's widow, participated in the ceremony. Long-time political friends of the Nikkei community, former Governor Mike Lowry and Seattle City Council Jan Drago showed support by joining the community event.

In addition to Nisei Veterans Committee members and Steve Finley, Lt. Colonel Edmund Haraguchi, Chief of the Logistics Division at Madigan Army Medical Center in Tacoma, worked tirelessly to get approval from the Commander of Madigan, the Commander of the Dental Command, the Commander of the Western Regional Command, and the Commander of Fort Lewis before he could take it to the Surgeon General and Army Headquarters. Steve reports that Lt. Col. Haraguchi received strong support from each of these leaders.

An exhibit chronicling James Okubo's life is placed at the entrance of the clinic and numerous Aki Sogabe prints adorn walls throughout the building.

T/5 Okubo was presented with the Congressional Medal of Honor posthumously in June 2000. In a moving tribute, General Shinseki said that James Okubo, his two brothers and two cousins, all volunteered and were assigned to the 442nd Regimental Combat Team even as their families were confined in Tule Lake and, later, Heart Mountain. His brothers suffered disabling wounds, and one cousins killed.

The following is an excerpt from the program booklet covering his heroism: "T/5 Okubo, a medic, crawled 150 yards to within 40 yards of the enemy lines. Two grenades were thrown at him while he left his last covered position to carry back wounded comrades. Under constant barrages of enemy small arms and machine gun fire, he treated 17 men on 28 October and 8 more men on 29 October. On 4 November, T/5 Okubo ran 75 yards under grazing machine gun fire and, while exposed to hostile fire directed at him, evacuated and treated a seriously wounded crewman from a burning tank, who otherwise would have died. T/5 James K. Okubo's extraordinary heroism and devotion to duty are in keeping with the highest traditions of military service and reflect great credit on him, his unit and the United States Army." "Oriental" Bill Becomes A Law

1) Engrossed Senate Bill 5954 requires that, as of July 1, 2002, all state and local government statutes, codes, rules, regulations, and other official documents are required to use the term "Asian" when referring to persons of Asian descent. The use of the term "Oriental" is prohibited.

2) Urges all state and local entities to review their statutes, codes, rules, regulations, and other official documents and revise them to omit the use of the term "Oriental" when referring to persons of Asian descent.

3) Declares that, as used in RCW 35.22.650, the term "minority business" means a business at least fifty-one percent of which is owned by minority group members. Minority group members include, but are not limited to, blacks, women, native Americans, Asians, Eskimos, Aleuts, and Hispanics.

Passed by the Senate: March 11, 2002, Yeas 42, Nays 2 Passed by the House: March 6, 2002, Yeas 86, Nays 6 Governor Locke signed ESB 5954 on April 2, 2002. ESB 5954 is effective July 1, 2002.

President's Message

hough there were several events that were truly memorable during the past month, I must admit that the one that made me most proud involved the naming of the beautiful new medical and dental complex at Fort Lewis for Congressional Medal of Honor awardee Medic James K. Okubo. Though the day was overcast, windy and rainy, the bright spirits of pride and victory made the gloomy day seem inconsequential. We were honored with the presence of the Army's Chief of Staff General Eric Shinseki and Governor Gary Locke. It was obvious that he has not forgotten his roots in the Japanese American community in spite of his spectacular ascension into the highest ranks of the U.S. military establishment. We should be proud that a state of the art medical and dental complex has been named for a hero of Japanese ancestry. We can also be proud that today the highest position in the U.S. Army is held by a Japanese American.

I attended the 57th Annual Nisei Veterans Committee Installation Banquet and was very surprised to see a very large group of veterans, wives, children, and grandchildren because it was snowing heavily that afternoon. Again, I had an opportunity to hear a speech by an articulate Japanese American military person, this time a representative of the U.S. Navy. Captain David Yoshihara, who is in charge of operations for U.S. ships in the North Arabian Sea, presented interesting comments about his service on the USS Carl Vinson. The Vinson is a major launching pad for 200 aircraft fighting in the war in Afghanistan. While he showed videos that depicted the destructive nature of war, he also deviated from his wartime recollections to express gratitude for his Japanese American heritage. He noted that the success of future generations is dependent on generations helping each other and families that are close and nurturing.

After those proud days, a National JACL news alert snapped me out of thinking that maybe, just maybe, the state of race relations was improving. The subject of the news alert was the

vitriolic attack on the Secretary of Transportation Norman Mineta by syndicated columnist Ann Coulter. The contents of that article serve as a grim reminder that respect for people of color even Presidential Cabinet level people of color, has not changed much. The article in question, which was distributed to major

news outlets by Universal Press Syndicate and its parent company, Andrews McMeel Universal, suggests that "Secretary Mineta is burning with hatred for America — he's subjecting all of America to the Bataan Death March!" Her article trivializes the wartime experience of Japanese Americans and criticizes Secretary Mineta for correlating what happened to Japanese Americans with the recent attacks against Arabs and Muslim Americans. The columnist's cynicism and racism came through loud and clear, clearly a discredit to an otherwise worthy profession.
