# **Beautification Day Aki Kurose School**



# National Youth/Student **Council Funding Boosted**

n planning for the upcoming biennium, JACL National faced many difficult budgetary decisions. Not immune to these decisions were the budgets of the two main national youth/ student programs - the National Youth/ Student Council and The Biennial National Youth/Student Conference. Each of these two programs were budgeted minimal amounts of hard monies. Recognizing the need for JACL National to provide consistent and stable funding for such a high priority for the future, the Seattle Chapter was proud to play an integral role in restoration of funds to these two programs.

The Seattle Chapter signed on as a sponsor to a National Youth/ Student Council-generated floor amendment that would have specified a "floor" amount of membership dues to be devoted to providing consistent funding for National Youth/ Student programs. The amendment, which failed by a slim majority, managed to generate a vital discussion among convention delegates with regard to funding for youth programs.

Later in the same afternoon, during budget negotiations, the Seattle Chapter and Pacific Northwest District played a vital role in passing a nearly unanimous budget amendment that provided National Youth/ Student programs with stable funding for the 2002-2004 biennium.

Thanks to the leadership of Seattle Chapter delegates, JACL National will strengthen its commitment to investing in the future of our organization.

A renewed sense of purpose and dedication to our central mission of civil rights for Americans of Japanese ancestry...and all Americans...was certainly evident at the 37th Biennial JACL National Convention in Las Vegas. It was also heartening to see young Seattle-area leaders join other young Nikkei from many parts of the country in assuming important leadership positions within our organization.

There were numerous luncheons, receptions, dinners, workshops, committee/district meetings and plenary sessions at the Riviera Hotel. The following is a brief summary of the Convention highlights.

### **Reports to National Organization**

Ryan Chin presented an excellent overhead presentation on his work as National Vice President for Public Affairs. Matthew Tatsuo Nakata, incoming Seattle Chapter President, summarized his work as Chair of the National Youth/Student Council succinctly and ensured that funding would be dedicated to youth programs. His two-year stint as Chair of the Council helped to ensure a brighter future for the youth/student movement. We are all so proud of Ryan and Tatsuo's achievements.

### Officers

Maya Yamazaki, a Seattle Chapter member and delegate from the Pacific NW District Council, easily won election to follow Tatsuo as National Youth/Student Chair. Doug Honma, the Seattle Chapter's youth representative, drew a lot of interest to the Kaizen group through flyers that he distributed widely. Many chapters were very interested in this model to attract young people to community service through the JACL.

Ryan Chin easily defeated his opponent in his race to become V.P. for Membership. He drew accolades from President Floyd Mori and National Director John Tateishi for his 5-step proposal to increase membership in the national organization.

David Hayashi of the Lake Washington Chapter, was elected V.P. for Planning and Development. David provided able leadership in developing the 2003-2004 Program for Action.

Floyd Mori was re-elected to be President. Others who won elections included Art Koga, Secretary/Treasurer; David Kawamoto, V.P. for General Operations; and Ken Inouve, V.P. for Public

Wayne Nakamura, manager of multicultural markets for Stat Farm Insurance, longtime supporter of many API causes and Seattle Chapter member, was one of three JA of the Biennium award winners. Astronaut Daniel Tani and WMBA star Lindsay Yamasaki also received the prestigious awards.

Morris Dees, founder and director of the Southern Poverty Law Center, was honored with the Edison Uno Civil Rights Award following his inspiring speech at the Sayonara Banquet. Those of us in the audience felt equally honored to have the opportunity to listen to his important and inspirational words.

### Resolutions, By-laws and Budget

Bill Tashima presented eloquent and convincing remarks supporting the resolution urging the Boy Scouts to rescind their ban on gay leaders. After defeating an amendment to the resolution, the measure passed by a large margin. Bill served as an alternate delegate for Seattle and was of tremendous help as we worked to sort out all the parliamentary procedures, amendments to resolutions and by-laws changes. May Namba, our other alternate delegate, was Mrs. Dependable as always and filled in for me during budget deliberations.

Though Tatsuo did not run for National office, he left his mark on the organization and, in the process, ensured a stronger presence for young people as programs and policies are considered by the National Board. He worked diligently on a by-laws amendment increase funding for a national youth director and youth programs. When that failed, he persevered to get increases for youth programs during budget deliberations. As he worked the room, I could envision his transformation into another State Representative Kip Tokuda...or Congressman...or Senator.

With the help of Clarence Moriwaki who provided background on the Eagledale Ferry Dock memorial, the Seattle Chapter's Bainbridge Island resolution passed with no opposition. Dr. Frank Kitamoto and Clarence of the Bainbridge Island WWII Nikkei Internment and Exclusion Memorial Committee put up an impressive display in the Convention's exhibit room.

A very timely and important emergency resolution was one presented by Hugh Burleson, president of the Lake Washington Chapter, on banning the use of ethnic names as school mascots. The resolution passed with one strengthening amendment to expand the ban to include all kinds of teams.

A by-laws change eliminating the Mountain Plains District successful passed. The District will merge with other Districts. Another by laws proposal to eliminate four V.P. positions for Public Affairs, Operations, Planning and Development and Membership failed.

The Las Vegas Chapter worked tirelessly to organize a smoothly run convention. It was the perfect setting for a productive and fun time for all who attended the Convention. Now, on to Honolulu in two years!
