Seattle Chapter JACL pre-retirement workshop a success

The Seattle Chapter JACL's Aging and Retirement Committee conducted a six-week pre-retirement workshop for the Nikkei community at Sand Point Education Center in Seattle. The workshop included expert guest speakers, exercises and discussion, and detailed workbooks prepared by the American Association of Retired Persons.

The first session, "Meaningful Use of Time" featured Mary Jo Stroh, Registered Nurse from Group Health Cooperative, who spoke about the rewards of time well spent and the importance of testing lifestyle options before retirement. The second session, "Housing and Lifestyle" evaluated alternative housing and locations based on one's desired lifestyle. The speaker, Pat Ness, from the State Department of Social and Health Services, also discussed issues such as safety and the importance of one's family and friends. "Dynamic Fitness" was the subject of the third session, with a presentation by Anne Ledell-Hong from the University of Washington School of Nursing, discussing a wellness approach to health. She discussed the importance of preventing illness through good nutrition and exercise.

Ray Larsen, from Group Services of Washington and Alaska, covered "Financial Security: Sources of Income, Social Security and Medicare." He also discussed insurance needs that should be considered before retirement. In the session "Financial Security: Personal Financial Planning," Cheryl Kitashima, a certified financial planner, reviewed reasons why people fail financially and talked about increasing income, decreasing expenses, and investing money before retirement. Alma Misako Kimura, Attorney at Law, presented the last session, "Legal Affairs and Estate Planning" in which she discussed wills, probate, power of attorney, living trusts, and how to take maximum advantage of the tax laws.

Redress Update

The District office of the JACL has received many questions in regard to the tax treatment of redress payments and the effect on public assistance programs. We would like to share with you information we feel may be of assistance to you.

For those who have already received a confirmation notice from the ORA, the reverse side of the letter included a *Taxes, Benefits, and Redress Payments* information sheet. This information sheet lists federally assisted benefits *not affected* by redress payments. It also states that all redress payments are exempt from federal taxation. **However, income earned on the principal \$20,000 (such as bank interest) is taxable unless you place the check in a tax-free investment.** State taxation is determined on a state-by-state basis.

In Washington state, on May 31, 1989, Governor Gardner signed into law a bill that exempts "restitution payments" and all income and resources derived from such payments for purposes of determining eligibility for public assistance. This information can be found in the Engrossed Senate Bill No. 6152. Section 816 subsection (13):

(13) For purposes of determining eligibility for public assistance and participation levels in the cost of medical care, the department shall exempt restitution payments made of people of Japanese and Aleut ancestry pursuant to the Civil Liberties Act of 1988 and Aleutian Pribilof Island Restitution Act passed by Congress, P.L. 100-383, including all income and resources derived therefrom.

According to Title 74 of RCW, public assistance is defined as follows:

(1) "Public assistance" or "assistance" — Public aid to persons in need thereof for any cause including services, medical care, assistance grants, disbursing orders, work relief, general assistance and federal-aid assistance.

Washington does not have a personal state income tax, therefore the redress payments along with interest earned are non-reportable, non-taxable.

Wing Luke Museum exhibit: Fifty years before and fifty years after

The Wing Luke Asian Museum, which recently received a \$16,000 federal grant for general operating expenses, is preparing an exhibit entitled *Executive Order 9066: 50 Years Before and 50 Years After*. This exhibit will cover one hundred years of Japanese American history in Washington state.

Executive Order 9066 will open on February 19, 1992, on the 50th anniversary of the signing of Executive Order 9066. The planning committee members are currently looking for photos, camp items, diaries, drawings, letters, poems, documents, programs, souvenirs, and anything else related to the Japanese American community that might be used in the exhibit.

2nd Annual Northwest Wellness Conference for Seniors

This year the Conference will be held at Ocean Shores, October 27 - November 1, 1991 and will be entitled "Walk on the Well Side ... One Step at a Time." The Conference will include speakers, informative interactive workshops, team planning, time for recreation and relaxation, and numerous opportunities to become healthier. The registration deadline for this year is past, but persons who are interested in next year's conference should plan to register next spring.

NW Asian American Theatre: *Twinkle*

The Northwest Asian American Theatre is running a world-premiere of Gary Iwamoto's most recent comedy, *Twinkle*, through June 30. The energetic comedy follows Susie Wong, a spunky Chinese All-American girl from Bellevue, Washington as she follows her dreams to Hollywood to become a star.

Gary Iwamoto also authored NWAAT's most successful show to date, *Miss Minidoka 1943*, and the hit comedy mystery-spoof, *Who Killed the Dragon Lady*. Iwamoto wrote *Twinkle* to explore the difficulties and stereotyping that ethnic performers constantly face. *Twinkle* is sponsored in part by the Motoda Foundation, the Seattle Arts Commission, and the National Endowment for the Arts.

The shows run Thursday through Saturdays at 8 pm with Sunday matinees at 2 pm at NWAAT, 409 Seventh Avenue S. Tickets are \$12 for adults; \$9 for students and seniors; \$6 for children under 13; and \$8 for groups of 15 persons or more. Tickets and information may be obtained by calling 340-1049.

Labor of Love: A Rice Farmer's Musical to be performed at Bumbershoot

Labor of Love is an original bilingual musical comedy about two rice farming families from rural Japan and southern Louisiana, and will be premiered in the U.S. at Seattle's Bumbershoot Arts Festival. Co-written, co-directed, co-produced and performed in both Japanese and English by a mixed cast of Japanese and American actors, *Labor of Love* is a first-of-a-kind multicultural collaborative effort. The 2-act play features country Cajun and Japanese music and dance by top Japanese and American performers.

Labor of Love begins its international tour in Japan on June 29. The U.S. tour will begin in Seattle on August 30 through September 2, followed by performances in eastern Washington, Portland, San Francisco, Iowa, Arkansas, Houston, and Louisiana.
