
January 27, 2001: Seattle Chapter JACL Installation Banquet

Conscience and the Constitution, an award-winning documentary on the largest organized resistance to the wartime incarceration of Japanese Americans, will air nationwide on PBS Thursday, November 30, 2000. (In the Puget Sound area, Conscience will air on KCTS/9, December 12, at 10 PM.) The powerful documentary is the first program to tell the complete story of the young men who refused to be drafted from the concentration camp at Heart Montain, Wyoming, until their rights were restored and their

tion, hate crimes, healthcare, social security and other concerns. ROAR has done a great job with trying to empower APA's through voter registration and voter education.

They named the Honorable Richard Ishikawa Judge of the Year, and awarded Attorney Rod Kawakami the Presidential Civil Rights Award. U.S. Assistant Attorney General for Civil Rights Bill Lan Lee gave the keynote address. Among his many topics were racial profiling and the growing number of hate crimes in the nation, calling these some of the top priorities of his office.

families released from camp. It was an act of civil disobedience that led to the largest trial for draft resistance in U.S. history.

The one-hour documentary was produced and directed by Seattle Chapter member Frank Abe, in association with the Independent Television Service (ITVS) and with funding provided by the Corporation for Public Broadcasting and the Civil Liberties Public Education Fund.

a variety of talented Asian performers while trying to raise money for their many social service programs. It was a night of fun and entertainment.

• September and October were especially filled with letter writing campaigns to our State Senators and Representatives for the passing of the Hate Crimes Prevention Bill, Native Hawaiian Sovereignty & Self-Dermination legislation, the support of Bill Lan Lee's appointment as Assistant Attorney General for Civil Rights and the naming of the Seattle Federal Courthouse in honor of William Kenzo Nakamura.

Currently, the Hate Crimes Prevention bill has passed the Senate but not the House. Representatives McDermott, Inslee and Smith voted for the bill and Representative Dunn voted against. The Federal recognition of Native Hawaiians passed the House but not the Senate. Senator Murray voted for the bill and Senator Gorton voted against. Bill Lan Lee was later officially granted his title. The House of Representatives passed the resolution for the Nakamura Courthouse with the help of Representatives Dunn and McDermott. It awaits passage in the Senate.

I also wanted to mention the recent passings of two of our Past Presidents, Dr. Terrance Masaru Toda, who was also our landlord, and George Fugami. Their contributions to JACL and the community are appreciated and will be long remembered.

Even though the year is quickly coming to an end, we still have much to do before 2001. Our anti-discrimination committee is always looking for more volunteers. The Day of Remembrance project which includes distributing Internment curricu-

lum to local schools is just gearing up. We need help selling ads and tables for the Installation Banquet. If you are interested in helping or becoming more involved in chapter functions please let me know.


