# 120,000 Tassel Tapestry

See the "120,000 Tassel Tapestry," a Seattle Cherry Blossom and Japanese Cultural Festival highlight this year. The tapestry is made up of panels that depict the Japanese American experience during World War II. This unique historical perspective is the project of eighth grade students from two Indiana middle schools. The students undertook the making of the tapestry after learning about the history of Japanese Americans as part of their school studies.

While displayed in Seattle, the Tassel Tapestry is cosponsored by the MIS-Northwest Association, the Nisei Veterans Committee, and the Japanese Community Service (JCS) of Seattle. The Seattle JACL will be assisting the JCS by providing monitors for the tapestry on Sunday during the festival.

The annual Seattle Cherry Blossom and Japanese Cultural Festival will be at the Seattle Center from Friday, April 18 through Sunday, April 20, 2003. The Seattle JACL has supported this event since the festival's inception. This event is the Pacific Northwest's premier showcase of Japanese culture featuring many displays and exhibitions of Japanese arts, crafts, food, and history.

# **USA Patriot Act**

The USA Patriot Act will be covered at a membership event held by the JACL Civil Rights Committee. On the heels of 9/11, the Congress, Senate, and the President passed the USA Patriot Act. In the name of national security, the USA Patriot Act was aimed at uniting and strengthening our country by providing "appropriate tools required to intercept and obstruct terrorism." However, the USA Patriot Act infringes upon basic civil rights, giving the government greater power to monitor, search, and seize information and property as well as imprison Americans without due process of law. Further, the USA Patriot Act places the government beneath a widening umbrella of secrecy.

**Community Building:** Consul General Abe is extremely interested in the Nikkei community, holding a luncheon where dialogue was initiated to address challenges facing the Japanese American community and to find ways for the Nikkei and Japanese population to work closer together. At this private luncheon, I had the distinct privilege of representing Seattle JACL. **Initiative 200:** In 1998, Seattle JACL partnered with several other organizations to oppose Initiative 200 (I-200) and its clearly negative impact on diversity in Washington. Proponents of I-200 suggested the initiative would eliminate inequalities in the workplace, contracting, and admissions (recent statistics show that the opposite has happened). Despite our effort, I-200 went into effect, leaving many concerned about diversity and questioning if the goal of equal access and opportunity for all Americans was being reached.
