Day of Remembrance

The University of Washington will hold a Day of Remembrance (DOR) program to commemorate the anniversary of Executive Order 9066 (E.O. 9066) that enabled the mass evacuation and internment of 120,000 Japanese Americans during World War II. A lesser-known outcome of E.O. 9066 was the similar evacuation and internment of 900 Aleut Americans from the Pribilofs and other Aleutian islands.

This year's program will focus on these Aleuts. The physical, social and medical conditions for the Aleut Americans in the internment camps were abysmal. As a result of their incarceration, ten percent would die.

The program will include two Aleut American elders and a Japanese American from Alaska who will talk about their World War II experience. A new PBS video production by Marla Williams on the Aleut American story will be previewed. Ms Williams will also discuss the making of the video.

The public is invited to attend this program. The date will be February 19, 2004 from 7:30 - 9 PM at the University of Washington.
