Attending the 38th Biennial Japanese American Citizen League National Convention was a great opportunity. I am very glad to have went and would recommend this conference to all Japanese American youth. I know, some youth might be hesitant to attend, thinking that it's nothing more than just some boring old conference full of boring old adults. However, it wasn't that at all. It was educational and inspiring and also enjoyable.

There were workshops on a variety of topics ranging from US-Japanese relations to Pidgin, from hate crimes to ethnic dance, from native Hawaiian rights to Hapa's and to same-sex marriage. These workshops and gatherings gave me a chance to converse about issues on a level that I'm not able to with my friends at school. They dealt with issues that will affect me, such as job prospects, future opportunities and my civil rights.

There were also fun, laid-back activities to do as well. On the agenda there was a "Waikiki Welcome Mixer," a Sayounara Banquet included dancing, and one evening there was even an Obonodori at Queen's Park, just across the street from Waikiki Beach. Other activities were the nightly malasada (Portuguese donuts) and ice cream socials. If you had some down time in between sessions you could always go swimming at the hotel pool, relax on the beach right out front, or go shopping at Ala Moana Mall.

## APIs say NO to I-892

A 50-member coalition of Asian and Pacific Islander (API) elected officials and community leaders has organized to oppose the massive expansion of convenience gambling proposed by Eyman's Initiative 892 (I-892). I-892 is a November ballot initiative that would more than double legal gambling in Washington. It allows neighborhood restaurants, taverns, bowling alleys and card rooms to add 18,000 new electronic video slot machines, in as many as 2,000 establishments, more than 90 times the 22 tribal casino locations.

## Bainbridge Island Memorial project achieves milestones

The proposed national memorial (Nidoto Nai Yoni - "let it not happen again") has taken some big steps closer to becoming a reality, located at the site of the old Egleddale ferry landing where the first Nikkei in American history were sent to internment camps during WWII.

The City of Bainbridge Island gave an enthusiastic green light for the memorial, with unanimous passage of a resolution that allows work on Phase I to officially begin.

Community readings of the book, "From Our Side of the Fence" were held at Blaine Memorial Methodist Church on Friday, September 10th and at the Nisei Veteran's Hall on Saturday the 11th. Two readers from San Francisco told their own stories from the compilation of essays written by Nisei who were youth at the time of the internment. Both readings were well attended.

After each night's reading, the floor was opened for a question and answer session. During the session, discussion of a writers group in Seattle began to form with enthusiastic support from the crowd and encouragement from the guest readers. The readers felt that this was their way to leave a history for their grandchildren and that we should do the same.

Alan Yabui will explore the idea of a writers group in Seattle through Bellevue Community College and Brian Dempster, editor of the book, is willing to lead the group on a periodic basis. Further, Dee Goto will proceed with the idea of having a Nisei writers group, which will meet on Wednesday afternoons at the Japanese Language School, future site of the Japanese Cultural Center. These signs were also all over Kalakaua Avenue in Waikiki.

With representatives from King, Pierce and Snohomish counties, this coalition is working to inform their communities around the state about the impact I-892 will have on their families, their neighborhoods and their quality of life.

"I-892 will particularly hurt communities of color as well as disrespects our nation's commitment to tribal sovereignty," Joy Shigaki, Seattle JACL President Elect. "It is our responsibility to support the rights of Washington State's Indian Nations."

The revenue generated by tribal casinos goes to funding critical education, health care and other fundamental services and resources within the tribes, strengthening their self-sufficiency. In addition, some tribes who have been successful are now providing support to other communities in dire need of resources and services.

More than 150 API individuals and organizations have already endorsed NO on I-892, including the Seattle JACL. Key supporters include Asian Pacific Directors Coalition, Asian Pacific Islanders Coalition - King County, Asian Pacific Islanders Coalition - Pierce County, Filipino American Herald, Filipino Community of Seattle, Greater Seattle Chapter of the Organization of Chinese Americans, Lake Washington Chapter of the JACL, Kin On, Korean American Voters Alliance, National Federation of Filipino American Associations Region VII, Refugee and Immigrant Parent Advocacy Network, Vietnamese Economic Development Association, Governor Gary Locke, State Representative Sharon Tomiko Santos, Former Seattle City Councilmember Dolores Sibonga, and Former State Representative Kip Tokuda.

The memorial committee can now spend the \$500,000 state grant awarded last year, funds which must be used by June 2005 or they will be lost.

The grant covers final design work, site clearing and grading, stabilizing the shoreline, protecting a nationally historic cedar tree from falling into Eagle Harbor, an interpretive kiosk and signage.

The city will waive all permit fees, remove a pump house, construct a new access road and parking, and provide staff to coordinate the grant and construction project.

Last year the Timber Framers Guild offered their talents to build the interpretive center. However, depending on fund raising, construction on the center may not begin until Phase II or III, so in the mean time the Guild offered to design and build the entry gate at no expense.

The gate blends classic Pacific Northwest design with inspiration from traditional Japanese elements. Temporarily located in front of the Winslow Post Office as an informational kiosk, the gate will later be moved to the finished memorial.

The entire memorial including a pier, interpretive center and contemplative areas is projected to cost \$4 million. Approximately \$600,000 has been raised to date.

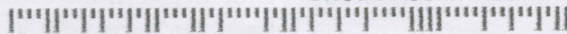
