What is a strategic plan and its purpose/goal?

A strategic plan is a five-year roadmap for the organization's future based on information gained through the organization and community input. The purpose/goal is to ensure that the organization is moving in a positive and clear direction to remain relevant and fiscally viable for the future.

Why are we doing this, and why now?

As a membership driven organization, we need to respond to the rapid changes in the community and because our traditional membership base is diminishing.
