Ehren Watada Update

Seattle JACL was recently asked to provide feedback on this resolution that was voted on at a National JACL council meeting.

MOTION: The NCWNP District Council agrees with the Watsonville-Santa Cruz chapter and believes that Lt. Watada has not received a fair trial. The NCWNPDC believes that all American citizens have a right to a fair and impartial trial, which includes the right to present evidence in one's defense, to have a trial presided over by an impartial judge and to be protected from double jeopardy. We call on the National Board to take the same position, generate a strong public statement and exercise leadership by engaging in activities including but not limited to: writing letters of support to the two courts hearing the case and directing our National Executive Director to educate other organizations and gather further support.

The Seattle JACL Board weighed in on the Watada issue, and wanted to make the rationale known to the JACL membership.

Originally, when JACL chapters were asked to weigh into the Watada issue, we were asked to be proponents of his beliefs about the War. Though many of our members were divided on their beliefs on the War in Iraq, we examined the issue based on JACL's mission, and the resolution that specifically stated that JACL does not comment on national policy. We determined that the issue itself was beyond the scope of the National JACL charter.

The latest resolution by the NCWNP District calls into question, not Watada's beliefs, but his rights to receive due process by the military code of justice. This

question of fairness is most certainly within the caveat of JACL's mission. When JACL is asked to weigh in on whether the civil ights of any American citizen is violated, it is up to us to take

a leadership position and be an advocate against such actions. That being said, the Seattle JACL felt this particular

resolution speculates on the fairness of the trial without sufficient information. The Seattle JACL proposed a counter amendment to this resolution by requesting that JACL commission an investigation as to whether Watada's civil rights have been violated. We were, through the district, outvoted for the amendment.

However, nationally, JACL took a similar amendment into consideration and nationally, JACL passed the amendment with all districts except for the Pacific Northwest voting to accept the amendment. Seattle JACL will continue to advocate for the rights of Ehren Watada to receive proper due process for his trial.
