Seattle JACL Introduces New President, Board

The Seattle JACL is pleased to announce its 2013 Board of Directors. One hallmark of this year's board is the large number of first-time sansei, yonsei and even gosei members, including: Toshiko Hasegawa, Keilene Kubota, Naomi Mittet, Umeko Motoyoshi, Gabrielle Nomura, Patrick Oishi, Cara Peterson, June Sekiguchi, and Paul Tashima. Additionally, we are also delighted to welcome Sheldon Arakaki and Hugh Burleson, from the Take Washington JACL Chapter, to our board.

Heidi Park is our 2013 Chapter President. Heidi has been an active board member for the past few years. An adopted Korean American, Heidi represents the diversity of the Seattle JACL as a voice for the Asian American civil rights movement.

Heidi shares a similar beginning with many Korean adoptees: She grew up away from her homeland of Seoul, South Korea, and in the foreign environment of the Midwest where her family and friends were predominantly white. Her racial identity has driven her down the path toward working with communities of color, where she quickly became interested in public policy, institutionalized racism, and community organizing. This is what drove Heidi to join the Japanese American Citizens League. Heidi currently works as a Policy Analyst for Mayor Mike McGinn. Most recently, she served as a Community Liaison and Caseworker for U.S. Representative Jim McDermott. Previously, she was an organizer with the Win/Win Network in Washington State where she created a series of statewide workshops with the AAPI community. She graduated with degree in history from The College of Saint Benedict/ Saint John's University.

With Heidi's leadership, the experience of veteran board members, and the enthusiasm and engagement of our new members, the Seattle JACL looks to continue our chapter's legacy as a leading catalyst for civil rights, civil liberties, and social justice.

spend much quality time together in airports, public transport and meeting rooms. Who's Hugh Burleson? I grew up in Southern California and in 1944 entered U.C. Berkeley. Drafted into



the army in Spring '45, some months later, I was en route to the Allied Occupation of Japan. There in 1947, I married Kimie in Yokohama, which

shaped the course of my life. Back in the USA with my young family in fall 1950, I re-entered U.C. Berkeley. With the new immigration law of 1954, Kimie immediately applied for citizenship. We knew the JACL had pushed for that reform; and Kimie's sense of on to the JACL, led Kimie to sign us up for membership, which we never let lapse. In 1956, with my U.C. work done

and Kimie now a citizen, I applied for a position with the U.S. Information Agency. We moved to Washington, D.C., and I began a 31-year career in the Foreign Service. We served 12 more years in Japan and 2~3 years each in Vietnam, India and Korea, plus further time in Washington, D.C. When I retired from government service in 1987, we settled here. I began a "second career"—volunteering with JACL, the World Affairs Council, Japan America Society, sister city organizations and with Bellevue's Aki Matsuri. I have filled several positions in the Lake Washington JA(chapter (now dissolving), and at the district level. This life was an adventure enough, especially with Kimie at my side until she passed on in 2001, that I was moved to set down the details in *The Making of a* Pacific Citizen (listed with Amazon.com).

My name is Toshiko Hasegawa. I am a 24-year-old Piscean hapa and the 4th generation of my Japanese



family to live here in Seattle. Raised on Beacon Hill, I was 14 when I first got involved in public service/youth leadership with the Seattle Youth Involvement Network. At GHS, I stayed active in a number of clubs. When I graduated in

2006, I skipped college aps and left immediately for Central America where I stayed until 2007, earning myself a unique international perspective. I returned, began working in the restaurant industry, and started applying to colleges when I was summoned to jury duty. I sat on a case where a 15-year-old API youth was being tried as an adult for attempted murder. The experience was powerful and intriguing, such that I

then applied to Seattle University's Criminal Justice Program, was accepted, and began my studies in 2008. I graduated just 2 years later with a double major in Criminal Justice and Spanish. I continue to work in a restaurant part-time, and spend the other part of my time brking in the public's interest. The following is a list of the people I work well with: all people, no people, defendants and dead people.



My name is Naomi Mittet, and it is a great honor to be a part of the JACL board. Here is a bit about me: I am a mom, an artist/graphic designer, and a student. I am currently getting my second B.A. in Special Education. My mother was born in Yamaguchi, Japan and I have very fond memories of spending time with my grandparents there.



Umeko Motoyoshi is a sansei hapa Japanese American whose family was interned at Heart Mountain, Wyoming. Inspired by the strength and resistance of her family, she seeks to promote fair and just treatment for all people. Through her management position at Fuel Coffee, Umeko organizes community events for occasions such as Loving



She enjoys spending her free time with her cat, Illuminati.

The Many Benefits of Planned Giving

Many donors assume the only way to make a gift to JACL is through an outright gift or a transfer of an asset like cash or real estate. While these gifts are certainly welcomed, there are other methods that allow members to support JACL as well as achieve their own strategic goals for their families.

With "Planned Giving," members are given significant tax deductions and savings for their gifts to JACL. This is the government's financial reward for your generous philanthropy.

JACL supporters may not realize they may continue to receive income from assets that have been transferred. But through planned giving, it is possible to make a tax-deductible gift to JACL while retaining the right to use the asset or to derive income from it.

Through planned giving you could:

- minimize taxes from IRA or other pension plans if retirement is subject to estate and income taxes.
- exchange highly-appreciated assets for a lifetime income stream plus a tax deduction by using a charitable trust.

Following is a sampling of some of the most popular planned giving instruments available.

Wills/Bequests/Living Trusts

These are an effective way to provide for a loved one's financial security and to ensure that the donor's assets are distributed as desired after the donor's death. A bequest in a will or a trust beneficiary designation is especially appropriate for someone unable to

make an immediate gift but would like to support the many activities and programs of JACL.

Outright Gifts

Gifts of cash, securities, real estate, insurance and personal property provide an immediate tax deduction of up to 50 percent of the donor's adjusted gross income with a five-year carryover.

Charitable Trusts

Charitable trusts are trusts established when a donor's assets are transferred to a trustee for the benefit of JACL. The donor would receive income for as long as he/she lives or for a fixed term. Don is eligible for substantial tax benefits. Donor eliminates capitalgains tax on any appreciation. At the donor's death the remainder of trust is transferred to JACL.

Using the experience of veteran planned giving expert Steve Okamoto, JACL would work closely with you, your family members or your financial and legal advisers, to provide helpful information to determine how various planned giving instruments or techniques would work best for each individual

National JACL Scholarships Announced

The Japanese American Citizens League (JACL) announces L its National Scholarship and Awards Program for the 2013 academic year. The JACL annually offers approximately 30 college scholarships for incoming college freshmen, undergraduates and graduates, and those specializing in law or the creative/performing arts. There is also a scholarship for those in need of financial aid in this time of rising tuition costs.

Making its debut in 2013 is the newly-created Meiji Gakuin University - JACL Scholarship for a graduating high school senior who wishes to study in Japan. Founded in 1863, this Tokyo-based university is one of the oldest educational institutions of its kind in Japan. This four-year scholarship will lead the recipient to a bachelor's degree in International Studies. All classes are taught in English.

Freshman applications must be submitted directly by the applicant to his/her local JACL chapter by March 1. Applications for the "other" scholarship categories (undergraduate, graduate, law, creative/

performing arts, and student aid) are to be sent directly by the applicant to the "National JACL Scholarship Committee" by April 1.

The application process for the Meiji Gakuin University - JACL Scholarship involves two different applications, which can be requested directly from Meiji Gakuin University.
